## **Smt. Sanjeevani Hari Raykar**

We are extremely grieved to inform our esteemed well-wishers and sponsors of the sad demise of Smt. Sanjeevani Hari Raykar, Founder Trustee of Vatsalya Trust Mumbai. Smt. Raykar started her onward journey on 5th February 2022 at a ripe age of 86.

It was always a pleasure to interact with Smt. Raykar; who had a very pleasing personality, fair complexion, broad forehead, a resonant voice and a great role model who practiced a very simple living style. A teacher at heart, with a huge student following from Bal Mohan Vidya Mandir, Dadar; Smt. Raykar effortlessly achieved a hat-trick of being elected as a MLA for 3 consecutive years. Smt. Raykar was a natural leader of the teacher fraternity and contributed very meaningfully in her role as the Chairman of the Shikshak Parishad.

In Feb 1983, Smt. Raykar along with socially conscious veterans like Late. Shri S.D. Athavale, Late Shri. Anantrao Kulkarni, Late Shri Vinod Nijure and Late Shri Gajanan Damle decided to start an orphanage for abandoned and destitute children in Mumbai. As a first step, Smt. Raykar herself spent two months at 'Matruchaya' an institution in Goa, where she observed and understood the intricacies of running of an orphanage. Thus, was born Vatsalya Trust Mumbai on 8th Feb, 1983.

Her selfless service in championing the cause of these destitute and abandoned orphans and the culture of empathy and love which she inculcated in the workings of Vatsalya Trust Mumbai has only improved with time and has helped grow the organization to a renowned social organization in Maharashtra. As an outcome of her relentless efforts, adoptive mothers can now avail child-care leave for 3 months. She could also get legal rights for adoptive mothers giving them much satisfaction and solace. Besides Vatsalya Trust Mumbai, Smt. Raykar also contributed towards social causes championed by many other social organizations.

In October 2020, Smt. Raykar contracted Corona but with her enviable zest for life, she fought through it and became healthy again. Unfortunately we lost Smt. Raykar on 5th Feb, 22. Even today, it is difficult to believe that Smt. Raykar is not amongst us and guiding us.

We owe it to Smt. Raykar, that we continue her good work with equal sincerity, love and passion. This can be the only true Shradhanjali we can offer..... Om Shanti !

During the year on 10.12.2020 ISO Auditor Mr. Vidyadhar Apshankar did Audit and ISO Certification of Vatsalya was continued for above projects and as well as granted for Orphanage and Adoption center at Kanjur and Balikashram at Sanpada.

### **ANNUAL INSPECTION**

The officials of Mumbai Suburban District Women & Child Welfare Department of Maharashtra State pay visits to the Trust from time to time and inspect the registers maintained by Vatsalya and give valuable suggestions, which are followed immediately. The cleanliness at Vatsalya, quality of food being served to the children was very much appreciated by all of them.

During the year due to Covid -19 pandemic only online inspection was done as Kanjur and Sanpada.

We sincerely thank the cooperation extended and guidance given by all the government officials to Vatsalya from time to time.

The Annual Function of the Trust could not be held due to Covid -19 pandemic

### **ADMINISTRATION**

Vatsalya Trust, Mumbai has 11 Trustees. Out of 11 Trustees, 3 Trustees are permanent and the remaining 8 Trustees are substituted after every 6 years. However, 4 Trustees who have completed 6 years in office, retire after every 3 years. The meetings of the Trustees are held atleast once in every quarter and minutes of the meeting are recorded. Besides this, the trustees meet from time to time to take important decision. The Trustees take policy decisions and perform to achieve the goals as intended and aimed. In the meetings of the Trustees, significant issues are reported. Any policy decision, if required, is also taken in such meetings.

The meetings of the members of the Managing Committee are held every month. The Managing Committee Members are in charge of the day to day work of the Trust. The Trustees and the Managing Committee Members of the Trust do not accept any allowance or honorarium. Since inception of the Trust, it has not incurred any expenditure on any foreign tour.

## KANJURMARG

### SHISHUGRUH (Child Care Institution)

During the year **17** children were admitted to the Trust out of which **2** were transferred to other Institutions / parents. During the year, **23** orphan children were placed in adoption in loving families and **2** were transferred. It may be noted that **5** children were adopted by foreign nationals. During the past 38 years 1221 children have been given in adoption as on 31.03.2021. The Trust makes sincere attempt to remain in touch with all the parents and children.

At present **21** infants are residing in Vatsalya and there are **8** special need children. Thus total **29** children are under care and protection of Vatsalya. Besides these children, 6 other children, mainly Special Needs Children are admitted to other institutions for education and care. Expenses for these children are also borne by Vatsalya.

At Vatsalya we receive children who are even one day old. They are usually very weak, malnourished and underweight. Some of them are also ill when brought to the Trust. They are also very vulnerable to illnesses. Vatsalya's dedicated staff of caregivers referred as 'house mothers', sisters (nurses) and supervisors work throughout the day and night in order to save the life of the child and keep the child healthy. Because of their love, affection and hard work, the children at Vatsalya remain healthy and happy. I wholeheartedly thank the staff of Vatsalya for the humanitarian service provided by them.



## REHABILITATION CENTER

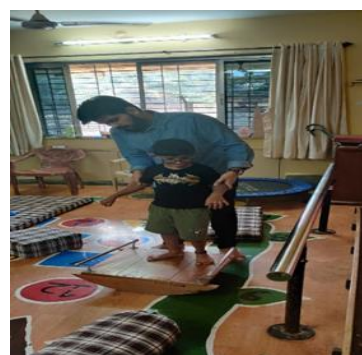
If the special need children are diagnosed earlier and if remedies are provided at an early age, the children show significant improvements which result in better and improved life for them in later years. Experts and special educators are required to train these children. The Rehabilitation Center was started in order to support the Special Children. The children mainly from Central Suburbs of Mumbai and also from far off places such as Thane, Dombivli, Ambernath, Badlapur avail the said facilities.

At Rehabilitation Center the professionals work towards achieving set goals and the development of the children with special needs so that genuine efforts are made to bring the child in the mainstream. Rehabilitation Centre supports children with any delay in regular development through children and parent guidance programs with supervised professional interventions.

The activities of Rehabilitation Centre encompass mainly three focus areas:

1. **Early Intervention (Aakar)** Centre which provides facilities like Physiotherapy, Speech Therapy and Occupational Therapy, Special Education to children who are at the risk of developing disability such as mental retardation, developmental delays and language/ speech problems.
2. **Child and Parent Guidance (Khushi)** – Khushi Centre caters to the need of the children with various issues such as behavioral, emotional and scholastic. The Khushi Centre handles above problems through Psychiatric Intervention, Family therapy, Therapy with Children, Parent's skill training and teachers sensitization programs.
3. **Outreach activity (Disha)** – Under Disha rehabilitation aids and equipment are provided to special need children by networking with other NGOs, professionals and various institutes.

Since 2005, **Rehabilitation Centre at Kanjurmarg** has more than 2000 registered cases and through the team of qualified professionals Vatsalya is providing therapy and treatment to about 125 children per week. During the year 200 children were treated at the Kanjurmarg, Sanpada and Alibag Branches of Vatsalya. Under the



Disha program, 100 children were provided with rehabilitation equipment such as orthosis and splints.

**Rehabilitation Centre at Sanpada** was started in 2016, where Physiotherapy for senior citizens was the initial activity. It is well supported by the interns from 'Terana Medical College'. Rehabilitation Centre for pediatric (Children) is also running successfully, with 30 registered cases.

**Rehabilitation Centre at Alibaug (Raigad)** was inaugurated on 15<sup>th</sup> August 2018. It was the most needed facility in this district. Vatsalya is providing quality service by qualified and expert professionals at very nominal rate or even free of cost to needy children.



Due to pandemic during the year the therapy sessions were mainly conducted online for all three units i.e. Kanjur, Sanpada and Alibaug and 150 children had registered for the same.



Camp for Orthosis : On 6<sup>th</sup> March 2021 Orthosis Camp at Alibaug was conducted of which 6 children availed benefits.

Camps for Hearing aids : Similarly on 6<sup>th</sup> March 2021, a camp was organized for the children with hearing issues in Raigad district at Alibaug in which 10 children were assessed and audiometry performed and they were given hearing aids. All the camps were conducted by Dr. Rushikesh Deshmukh.



### PATIENT ASSISTANT PROGRAM

Vatsalya is successfully conducting the Patient Assistant Program since 2006 at Kanjur.

During the year 2020-21, 31 girl students took admission for the said one year course. Similarly, 10 girl students were admitted at Sanpada center.

The students are taught anatomy for about four months by Dr. Smt. Jyoti Jadhav, Dr. Smt. Alka Bedekar, Smt. Chavan, Smt. Renuka Salgaonkar and Smt. Kshama Pendse. Thereafter for about four months practical training is imparted at Hiramongi Hospital, Mulund, Ganatra Hospital, Airoli and Indravati Hospital, Airoli. Vatsalya is grateful to the management of the said hospitals and the doctors and staff of these hospitals who have given invaluable guidance and support to the students.



The students are also imparted soft skills such as English speaking, communication and basic computer operations which helps them in getting seamlessly in modern hospital environment.

**Valvanda Centre :** Vatsalya has also made available the facility of training for 25 girl students at Valvanda Village, Wada Taluka in Palghar district. Vatsalya is bearing the entire cost of these students, including entire education setup, coaching expertise, registration charges, stationery, laboratory equipment, supply of grocery items etc. These students reside and study at Aandibai Ashramshala. The said center is being conducted with the help of Mauli Shikshan Prasarak Mandal, Walvanda.

During the year the course was mainly conducted online due to Corona. We intend to start similar Patients Assistant Program courses at Rajapur, Dapoli, Latur, Jalna in coming year.

For the last 6 years the Patients Assistant Program of Vatsalya is getting financial support from RPG Group under their project 'Sanjeevani'. Due to their invaluable help, the girls from economically weaker sections and from rural areas get opportunity to have respectable employment by obtaining further education.

### COMPUTER TRAINING CENTER

Vatsalya's Center for Digital Literacy for under privileged is being conducted since 2006 and the same is very popular amongst the students. During the year the training program, mainly online, were held at Kanjur and Sanpada.



The Centers at Kanjurmarg and Sanpada are recognized as authorized learning centers by MKCL (Maharashtra Knowledge Corporation Ltd.) for basic MSCiT courses and domain specific, job oriented advanced courses in KLIC ENGLISH, Desk



top publishing, Advanced Tally and Advanced Excel, thus enhancing the employability of young men and women from socially and economically backward section of the society by offering them job oriented computer courses at affordable fees. Additional life / soft skills and communication skills in English were also imparted to them and prepared them for employment.

Vatsalya intends to start similar computer courses at Kurla, Alibaug, Pali, Latur, Rajapur, Ratnagiri, Dapoli, Uttan (Bhayander) and Ulhasnagar.

## DRIVE WITH PRIDE



During the year 2020-21 total 99 students were benefited from Vatsalya's Drive With Pride initiative by acquiring driving skills through the said program. Out of these 79 students were from Talasari, Mokhada, Javhar of Palghar district. Other were from Taloda of Nandurbar district. Vatsalya collaborated with other NGOs working for the down-trodden and deprived segment of the society such as 'Shabari Sewa Samiti', Javhar and Taloda, 'Sneh Samaj Uddan Sanstha' Talasari and Parivartan Mahila Sanstha, Mokhada to give training to drive four wheelers to the youths, thereby increasing their employability as well as by creating job opportunities. It also opened new avenues of self-employment for these youths from mainly adivasi (aboriginal) part of Maharashtra. This will definitely help in their social and economic upliftment. One of the students of the said training program from Jawhar Mr. Santosh Tyagi purchased a Van with the help of loan. He is supplying grocery to the and nearby area, thereby increasing his income substantially. Training is being provided at Kanjurmarg to 20 students. They all are supplying grocery, food items and cakes thereby earning a reasonable steady income. One of the student Ms. Pooja Patel plies an auto-rickshaw after her regular working hours thereby helping the family to earn additional income. In association with 'Global Rights Foundation' Ulhasnagar, Vatsalya is planning to start Auto rickshaw Training program for the members of the third gender community, to create a source of income for them.

Similarly, Vatsalya is also planning to give training for Forklift and JCB operation for the needy persons.

## COLLECTION OF FUND

The wholehearted support from well-wishers like you is the foundation of Vatsalya. Your support in all forms is valuable. I wholeheartedly thank all the donors, without whose support it is impossible to run the institution.

For the last many years on the occasion of Ram Navmi similar center is conducted at Ram Mandir at Borivli. However, this year due to Covid -19 pandemic we could not conduct the said activity.



## **SANPADA SEWA PRAKALP**

Vatsalya started its Sanpada Sewa Prakash at Sanpada, Navi Mumbai. Various projects such as Balikashram (Home for Girl Child) , Oldage Home, Rehabilitation Center, Patient Assistant Program, Computer Training Program are conducted at the said project.

### **BALIKASHRAM**

During the year 62 girls were given shelter at the Balikashram. These are mostly the children who are destitute, orphans or are from economically weaker section from the age of 6 years to 18 years. These are admitted as per the Orders of Child Welfare Committee, Thane District, appointed by the Woman and Child Welfare Department of the Government of Maharashtra. Vatsalya takes care of all the needs of the



children such as shelter, food, clothing, education, health besides giving them emotional support. The girls go to Vivekanand School, Sanpada upto 10<sup>th</sup> standard. The educational progress of the children is satisfactory. We are thankful to the management, Principals, Teachers and staff members of the Vivekanand School for their wholehearted support to Vatsalya.

Due to Covid – 19 pandemic the schooling for the entire year was online. Teachers Mrs. Priyanka Makkar and Mrs. Megha Salvi as well as counselor Mrs. Juhi Chandra gave valuable guidance to the children, especially those in the tenth standard.

During the year (1) Ms. Kranti Padekar, (2) Ms. Sudha Ladi, (3) Ms. Savita Kamble, (4) Ms. Sayali Jawale, (5) Ms. Sayali Gangawane, (6) Ms. Urmila Pratap and (7) Ms. Priyajyoti Shetty were successful at the SSC i.e. 10<sup>th</sup> standard examination and they are now pursuing college education including vocational education.

Ms. Pooja Shinde graduated with BMS Degree.

Ms. Anjali Pawar completed her post-graduation in Computer Science with MSc degree.

**U & I Trust** : Throughout the year, the young volunteers of U & I Trust taught Mathematics to the children using online method. As there is one dedicated volunteer per child, there is a personal attention to the child as well as bond is developed which is crucial for the progress of the child. Considering the need of the online classes, U & I Trust also donated 4 Tabs for the use of children. We sincerely thank U & I Trust, Ms. Sanjana Rane and all her associates.

**'Yes I Can Trust'** : During the year children were given training in English language conversation by the volunteers of Yes I Can Trust using phone. We are thankful to its Trustee Ms. Neha Khare and the volunteers.

Even during the pandemic, the children celebrated Independence Day, Republic Day, festivals such as Gudi Padwa, Rakshabandhan, Shrikrishna Janmashtami, Shree Ganesh Chaturthi, Navratrotsav, Diwali, Christmas, Holi etc.

## **HEALTH**

Health check-up of the children is regularly done. During the pandemic special emphasis was provided to maintain good health. During the year only two children got mild infection and they recovered with timely diagnosis and treatment. The President of the Trust Dr. Ainapure also did health check-up. Dr. Mandhana and Dr. Mhatre who are having their dispensaries nearby, are always available to give timely treatments to the children. Dental health is looked after by Dr. Ganesh Shendge. We are also thankful to the doctors, sisters and staff of Navi Mumbai Municipal Hospital, Vashi and General Health Centre Sanpada Sector- 5 who give medical support the children even at odd time.

## **VRUDDHASHRAM**

At Sanpada project we also run a Vruddhashram alongwith Balikashram. During the year thirteen senior citizens availed the facilities of Vruddhashram. At Vruddhashram not only good care of their food and residence is taken but we also provide television facilities, newspapers, library etc. for their entertainment and relaxation. In the campus of Vatsalya there is a Shree Ganesh Mandir. However due to pandemic, admission to Vruddhashram was restricted.



## **ALIBAG SEWA PRAKALP**

The Alibag branch of Vatsalya Trust, Mumbai was inaugurated on 7<sup>th</sup> January 2007. The working and progress of the Alibag branch is satisfactory.

During the year total 13 children were admitted at the Alibag Project and 6 children were placed in adoption. In pursuance to the Order of Child Welfare Committee Alibag, four children were restored to their parents.

On 7<sup>th</sup> January, 2021 foundation day of Alibag project was celebrated in a subdued manner due to pandemic. Dr. Dhamankar, Dr. Aditya Chevle, Dr. Arvind Takale, Dr. Parvez Shaikh and Dr. Saurabh Patil look after the medical welfare and needs of the children. Dr. Hrishikesh Deshmukh, Dr. Manisha Meshram, Dr. Aaditi Gokhale and Dr. Tamboli treat the children who are availing facilities of Rehabilitation Center.
